



## NOTICE OF PUBLIC HEARING – EL CERRITO CITY COUNCIL


### MAXIMUM ALLOWABLE CITY OF EL CERRITO INTEGRATED WASTE MANAGEMENT FEES EFFECTIVE JULY 1, 2019 TUESDAY, JUNE 4, 2019– 7:00 p.m.

Notice is hereby given that the El Cerrito City Council will conduct a public hearing in the Council Chambers, located at El Cerrito City Hall, 10890 San Pablo Avenue, Tuesday, June 4, 2019 at 7:00 p.m., or thereafter, to consider setting the maximum allowable Integrated Waste Management Fee (IWM), effective July 1, 2019. The IWM Fee is one of three components included in the total solid waste collection and disposal costs paid by El Cerrito residents and businesses. This fee funds the City's recycling and solid waste reduction programs, including curbside recycling for residents and businesses and the operations of the Recycling + Environmental Resource Center. The proposed Fees listed below are monthly rates at one pickup per week (except Compacted and Roll-Off, which are as noted).
