NOTICE IS HEREBY GIVEN that the El Cerrito City Council will conduct two public hearings for fire hazard reduction.

1. Hearing to consider adoption of a resolution declaring that weeds, rubbish, litter, or other flammable material on certain real property constitutes a public nuisance; and adopting a resolution overriding objections by property owners and ordering the City Manager or his designee to abate certain public nuisances pursuant to El Cerrito Municipal Code Chapter 16.26.
2. Hearing to consider adopting a resolution confirming the cost of abatement of public nuisance conditions resulting from the presence of weeds, rubbish, litter or other flammable material on private properties designated in Exhibit A to the resolution as authorized by El Cerrito Municipal Code Chapter 16.26.


