NOTICE IS HEREBY GIVEN that the El Cerrito City Council will conduct a public hearing to consider setting the maximum allowable Integrated Waste Management (IWM) Fees, effective January 1, 2021. The IWM Fee is one of three components included in the total solid waste collection and post-collection (meaning transfer, transport, disposal and processing) costs paid by El Cerrito residents and businesses. The IWM Fees fund the City's curbside collection of recyclable materials, operations of the Recycling + Environmental Resource Center, and other solid waste collection and reduction and integrated waste management services. Fees listed below are monthly rates at one pickup per week (except Compacted and Roll-Off, which are as noted). The proposed 2021 monthly IWM Fees are:
