

## NOTICE OF PUBLIC HEARING – EL CERRITO CITY COUNCIL HELD VIA TELECONFERENCE

## MAXIMUM ALLOWABLE EAST BAY SANITARY COMPANY GARBAGE AND GREEN WASTE COLLECTION AND POST-COLLECTION RATES EFFECTIVE JANUARY 1, 2021

NOTICE IS HEREBY GIVEN that the El Cerrito City Council will conduct a public hearing to consider setting the maximum allowable rates for the collection and post-collection of garbage and green waste by East Bay Sanitary Company (EBS), effective January 1, 2021. The collection and post-collection (meaning transfer, transport, disposal and processing) rates are two of three components of the total solid waste costs paid by El Cerrito residents and businesses. Rates listed below are monthly rates at one pickup per week (except Compacted and Roll-off, which are as noted). The proposed 2021 monthly EBS rates are:
