whereas The City Council of the City of El Cerrito, by Resolution 80-10 passed and adopted on the 3rd day of March, 1980, duly called and ordered held in said city of El Cerrito on April 8, 1980, a general municipal election for the object and purpose of electing the following municipal officers of said City of El Cerrito:

- 1. That the certificate of the City Clerk of result of the canvass of election returns, now on file with the City Council, be and the same is hereby approved and adopted and is hereby entered on the minutes of the City Council as a statement of the results of said election.
- 2. That the whole number of votes cast in said City at said general municipal election was 4,690 votes.
- 3. That the list of candidates nominated for the offices to be filled at said general municipal election and the names of the candidates which were set forth in the petitions assembled and filed with the City Clerk as required by law, and the number of votes cast in favor of each of the candidates were as follows:

That the total number of votes given in each precinct in favor of said candidates was as set forth in the Clerk's statement of the result of said election.

4. That Jean B. Siri, Richard A. Spellmann, and Howard P. Abelson received the highest number of votes given for said office of city councilmember, and said Jean B. Siri, Richard A. Spellmann, and Howard P. Abelson were thereby elected councilmembers for the full term of four years, and the City Clerk is hereby authorized to sign and deliver to said Jean B. Siri, Richard A. Spellmann, and Howard P. Abelson a certificate of election and to administer to each of said persons the oath of office prescribed in the constitution of the State of California.
