

RESOLUTION 87-133

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL CERRITO DECLARING CANVASS OF GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 3, 1987, AND ACCEPTING CERTIFICATE OF THE COUNTY CLERK OF THE STATEMENT OF THE RESULTS OF THE ELECTION.

WHEREAS, the City Council of the City of El Cerrito, by Resolution 87-68 passed and adopted on the 15th day of June, 1987, duly called and ordered held in said City of El Cerrito on November 3, 1987, a general municipal election for the object and purpose of electing the following municipal officers of said City of El Cerrito:

Two (2) councilmembers for a full term of four (4) years, and

WHEREAS, pursuant to said Resolution 87-68, said general municipal election was held on Tuesday, November 3, 1987, in accordance with law, and the votes thereat received and canvassed and the return thereof ascertained, determined, and declared in all respects as required by the law, and the County Clerk of the County of Contra Costa has duly filed with the City Council a statement of results of said elections;

NOW, THEREFORE, BE IT RESOLVED, determined and declared by the City Council of the City of El Cerrito as follows:

1. That the certificate of the County Clerk of result of the canvass of election returns, now on file with the City Council, be and the same is hereby approved and adopted and is hereby entered on the minutes of the City Council as a statement of the results of said elections.

2. That the whole number of votes cast in said City at said general municipal election was 5089 votes.

3. That the list of candidates nominated for the offices to be filled at said general municipal election and the names of the candidates which were set forth in the petitions assembled and filed with the City Clerk as required by law, and the number of votes cast in favor of each of the candidates were as follows:

That the number of votes given in each precinct in favor of said candidates was as set forth in the Clerk's statement of the result of said election.

4. That Robert Bacon, and Jean Siri received the highest number of votes given for said office of city councilmember, and said Robert Bacon and Jean Siri were thereby elected councilmembers for the full term of four years; and the City Clerk is hereby authorized to sign and deliver to said Robert Bacon and

Jean Siri a certificate of election and to administer to each of said persons the oath of office prescribed in the Constitution of the State of California.
