

RESOLUTION NO. 3367

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL CERRITO DECLARING CANVASS OF GENERAL MUNICIPAL ELECTION HELD ON APRIL 14, 1970.

WHEREAS, the City Council of the City of El Cerrito by Resolution No. 3356, duly passed and adopted on the 9th day of March, 1970, duly called and ordered held in said City of El Cerrito on April 14, 1970, a general municipal election for the object and purpose of electing the following municipal officers of said City of El Cerrito:

Two (2) councilmen for a full term of four (4) years

AND WHEREAS, pursuant to said Resolution No. 3356, said general municipal election was held on Tuesday, April 14, 1970 in accordance with law, and the votes thereat received and canvassed and the return thereof ascertained, determined and declared in all respects as required by law, and the City Clerk of said City has duly filed with this City Council a statement of results of said election.

NOW, THEREFORE, IT IS HEREBY RESOLVED, determined and declared by the City Council of the City of El Cerrito as follows:

1. That the certificate of city clerk of result of the canvass of election returns, now on file with the City Council, be and the same is hereby approved and adopted and is hereby entered on the minutes of the City Council as a statement of the results of said election.


2. That Richard Bartke and Kenneth A. Berndt received the highest number of votes given for said office of city councilmen, and said Richard Bartke and Kenneth A. Berndt were thereby elected councilmen for the full term of four years and the City Clerk is hereby authorized to sign and deliver to said Richard Bartke and Kenneth A. Berndt a certificate of election and to administer to each of said persons the Oath of Office prescribed in the Constitution of the State of California.


