

RESOLUTION NO. 3504

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL CERRITO DECLARING CANVASS OF GENERAL MUNICIPAL ELECTION HELD ON APRIL 11, 1972

WHEREAS, the City Council of the City of El Cerrito, by Resolution No. 3492 passed and adopted on the 13th day of March, 1972, duly called and ordered held in said City of El Cerrito on April 11, 1972, a general municipal election for the object and purpose of electing the following municipal officers of said City of El Cerrito:

Three (3) Councilmen for a full term of four (4) years

and voting on the following measure:

Measure No. 1 - "Shall the Ordinance No. 294-N.S. entitled: An Ordinance of the City of El Cerrito Amending Sections of the El Cerrito Ordinance Code Rezoning Portions of Schmidt Village From R-1 and R-2 to R-1-S be adopted?"

AND WHEREAS, pursuant to said Resolution No. 3492, said general municipal election was held on Tuesday, April 11, 1972 in accordance with law, and the votes thereat received and canvassed and the return thereof ascertained, determined and declared in all respects as required by the law, and the City Clerk of said City has duly filed with this City Council a statement of results of said election.

NOW, THEREFORE, BE IT RESOLVED, determined and declared by the City Council of the City of El Cerrito, as follows:

1. That the certificate of the City Clerk of result of the canvass of election returns, now on file with the City Council, be and the same is hereby approved and adopted and is hereby entered on the minutes of the City Council as a statement of the results of said election.

2. That the whole number of votes cast in said City at said general municipal election was 7,215 votes.

3. That the list of candidates nominated for the offices to be filled at said general municipal election, the measures to be voted on at said general municipal election, and the names of the candidates which were set forth in the petitions assembled and filed with the City Clerk, as required by law, and the number of votes cast in favor of each of the candidates and the measure were as follows:

That the total number of votes given in each precinct in favor of said candidates, and that the total number of votes given in each precinct on the measure, and each thereof, was as set forth in the Clerk's statement of the result of said election.

4. That Gregory A. Cook, Gary MacLaren and Ernest Del Simone received the highest number of votes given for said office of City Councilmen, and said Gregory A. Cook, Gary MacLaren and Ernest Del Simone were thereby elected Councilmen for the full term of four years and the City Clerk is hereby authorized to sign and deliver to said Gregory A. Cook, Gary MacLaren and Ernest Del Simone a certificate of election and to administer to each of said persons the Oath of Office prescribed in the Constitution of the State of California.

5. That the City Clerk has certified that Measure No. 1: "Shall the Ordinance No. 294-N.S. entitled: "An Ordinance of the City of El Cerrito Amending Sections of the El Cerrito Ordinance Code Rezoning Portions of Schmidt Village From R-1 and R-2 to R-1-S be adopted?" was defeated at said general municipal election by a vote of:


