

RESOLUTION 2008-83

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL CERRITO RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD IN THE CITY OF EL CERRITO ON NOVEMBER 4, 2008, AND DECLARING THE RESULTS OF THE ELECTION AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Elections consolidated with the statewide general election was held in the City of El Cerrito on Tuesday, November 4, 2008 as required by law; and

WHEREAS, the qualified electors, including absent voters, cast ballots at said election for the following officials:

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes thereof were received and canvassed and the return thereof was ascertained, determined, and declared in all respects as required by the law, and the County Clerk of the County of Contra Costa has duly filed with the City Clerk a statement of votes of said election.

Greg Lyman


BE IT FURTHER RESOLVED, determined and declared by the City Council of the City of El Cerrito as follows:


