Mr. Guthrie requested to discuss with the new Senior Center Supervisor how to enhance the Easy Ride Paratransit Service's ticket system. He proposed in 2011 a ticketless transportation system. He suggested that registered passengers' fare can be automatically deducted from their account as they schedule a ride and without utilizing a card that is similar to clipper card. Ms. Bilbas replied that she is working on how to make it happen and would like to schedule a follow-up meeting with Mr. Guthrie.
