MINUTES



REGULAR MEETING OF THE ENVIRONMENTAL QUALITY COMMITTEE

Tuesday, January 13, 2015, 7:00 p.m. El Cerrito City Hall – Council Chambers 10890 San Pablo Avenue This Meeting Place Is Wheelchair Accessible

Miner called the meeting to order at 7:11 pm.

Roll Call:

Vice Chair Goudey, Members Benjamin, Schaadt, Weinstein, and Wildenberg

Absent: Chair Miner, Members Krueger, Solari, Spitalnik Also Present: Greg Lyman, City Council Liaison; Maria Sanders, Staff Liaison

1. **Council/ Staff Liaison Report** – <u>Sanders</u> announced that member <u>Solari</u> is currently on parental leave. <u>Sanders</u> reminded everyone to be on time, as starting the meeting late inconveniences other meeting attendees. She also announced that <u>Pavel</u> is considered to have resigned.

Goudy welcomed new Council Liaison Greg Lyman, who reported on Council actions since October, including: approval of the new Street Sweeping contract; adoption of the Integrated Waste Management fees and Garbage rates; voter approval of Measure R; adoption of an Ordinance to join Marin Clean Energy and adoption the new Housing Element. Lyman also announced that the new Smoking Ordinance takes effect Jan. 1, 2015.

- 2. **Comments from the public on non-agenda items** Trina Mackey introduced herself. Rebecca Milliken also introduced herself. Both have provided applications to join the EQC.
- 3. **Approval of the Minutes –** Motion to approve the minutes from both the November 12 and the December 9, 2014 meetings (<u>Schaadt/Weinstein/Unanimous</u>).
- **4.** Community Choice Aggregation (CCA) <u>Goudy</u> reported that the CCA ordinance will have a solid commitment from EQC to get the word out. <u>Sanders</u> gave update on next steps and the CCA outreach plan.
- 5. Trash Mitigation Strategies Goudy expressed an interest in the EQC exploring ways in which the EQC could contribute in helping the City manage litter and trash. Schaadt circulated the City's Trash Management Plan (contained for viewing in the EQC binder). He expressed a need for more trash cans in litter hot spots, including more frequent pick-ups where existing ones quickly overflow. Weinstein made a proposal to help develop an assessment of trash can needs throughout the City. Schaadt volunteered to help. Weinstein also suggested that the City and EQC take an active role in working with BART, other public entities, and business owners to keep their properties trash free. Motion to create an adhoc subcommittee, including Weinstein and Schaadt, to develop a plan to engage the EQC in trash mitigation efforts (Schaadt/Benjamin/Unanimous).

- **6. Pollinator Safe Communities** This item was deferred until <u>Solari</u> comes back from parental leave. Weinstein announced a new exhibition at the Oakland Museum on bees.
- 7. **EQC Workplan, Budget and Calendar of Events** Benjamin moved for the EQC to review the current Work Plan and prioritized projects to present to Council as part of their presentation on March 17 (Benjamin/Weinstein/Unanimous). Motion to hold the second Hillside Festival on May 17 or May 31 and the Music for Madera Festival on September 9 or September 27 to raise fund to support maintenance and restoration in the Hillside Natural Area (Weinstein/Schaadt/Unanimous).
- 8. Hillside Natural Area Open Space Fundraising—Weinstein announced that the property will transfer to the City near the end of January. The Open Space Campaign was able to raise over \$100,000 towards the purchase price, handily making its original goal.
- 9. **Green Teams: Update and Action Items** <u>Weinstein</u> announced the upcoming clean-up at both BART stations on Sunday, January 25. <u>Weinstein</u> and <u>Schaadt</u> will each lead a team in each station area. Motion for the EQC to co-sponsor with Trail Trekkers a Broom Pull in the Hillside Natural Area as the next Green Team, date in February to be determined (<u>Weinstein/Benjamin/Unanimous</u>).
- **10. EcoFilms** <u>Goudey</u> interested in a film showing this year, probably sometime in the fall. Pavel announced that the League of Women Voters is looking at several events in the near future.
