- 1. Council/Staff Liaisons Announcements and Reports <u>Provost</u> announced that MCE is working on developing programs to assist in EV adoption. MCE is looking into subsidizing the PG&E EV charging station program. <u>Provost</u> also mentioned that members can subscribe to sub-calendars on the city website to receive automatic updates for events. <u>Provost</u> announced that former member Hargrove resigned from the EQC.
- **2.** Comments from the public on non-agenda items –Steve Price, chair of the Urban Forest Committee, announced that Arbor Week will be March 7-14 and they would like to invite the EQC to join them for an ivy clearing event at Canyon Trail Park on March 10 or 11.
- **3. Approval of the Minutes** Motion to approve the Tuesday, December 12th minutes (O'Connor, Sobul, unanimous).
- **4. Contribute to Plaque for Centennial Tree** <u>Provost</u> announced that he spoke with Stephen Pree and the remaining funds needed for the plaque will be covered by the tree budget.
- 5. EQC Budget and Calendar of Events-

Committee members heard updates, participated in discussion and considered possible action items regarding planning, logistics, and expenditures for the EQC calendar of events, including:

 - Miner proposed that the film subcommittee come back with a detailed plan for the next EQC meeting.

6. Climate Action Plan Implementation

Committee members heard updates, participated in discussion and considered possible action items regarding implementation of the Climate Action Plan.

- MCE Deep Green Update-no new enrollments
- CCA & CPUC Updates
 - o CPUC Resolution e-4907 impacting future CCA programs
 - Would impact LA County and Central Valley, as well as cities that have not joined an existing CCA
 - Hearing 02/08/18 in San Francisco
 - Milliken announced that the Clean Power Exchange has resources where members can learn more.
 - MCE Deep Green Champion- El Cerrito is now listed on the MCE website as a Deep Green Champion that has opted up to 100% renewable sourced energy.
 - Provost announced that the city has joined the MCE Community Power Coalition, which brings organizations together to increase access to affordable renewable energy.
 - O <u>Provost</u> also announced that El Cerrito was ranked 13th in the country for the share of community wide electricity that comes from renewable sources and was given an award by the EPA.

- o MCE Community Power Coalition
 - <u>Milliken</u> announced that in order to be a member of the CPC, you must be backed by an organization.
 - <u>Miner</u> proposed asking Council for permission to be a member of the CPC.
 - <u>Provost</u> noted that EQC members can join as part of another organization.
 - Motion to recommend staff to look into bringing EQC's CPC membership to City Council (Tsutsui, Sobul, unanimous).

7. Parks & Recreation Facilities Master Plan-

Committee members heard updates on the El Cerrito Parks and Recreation Facilities Master Planning process.

- Goudey asked how new policy ideas should be introduced to city staff.
- <u>Provost</u> recommended creating ad-hoc subcommittees, writing an outline on the policies and setting up a meeting with the Building and Economic Development departments.
- <u>Goudey</u> noted that he would like to focus on three stream waste facilities and unit level metering for multifamily units.
 - o Ad-hoc Subcommittee created for multifamily related policy issues: <u>Miner</u>, <u>Goudey</u>, <u>Sobul</u>, and tentatively <u>Milliken</u> and <u>O'Conner</u>.
- Miner suggested the EQC propose that the city revisit and tighten CAP policies.

9. Announcements and future agenda items

Heard committee member announcements and suggestions for future EQC agenda items.

- Bike to Work day was announced for March 10
- Weinstein announced a Trail Trekkers meeting on January 20th with a talk entitled "Living with Lions".
- <u>Milliken</u> announced that the State has an earthquake Brace and Bolt program to help make homes earthquake safe. Rebates are available for qualifying El Cerrito residents.
- <u>Miner</u> announced that Goudey found a list of Fixit Clinics coming up and he will attend the one in March at the North Berkeley library.
 - o Goudey volunteered to be a Fixit coach for the clinic Saturday 1/13/18 in Oakland at the Dimond Branch Library.
- Pavel announced a Climate Change conference coming up on January 24-25 in Oakland.
- <u>Provost</u> welcomed <u>Kittleson</u> to the EQC.
- O'Connor announced that he would like to prioritize making signage for the Hillside Natural Area Interpretive Trail as well as the three stream waste policy.
