A. **Tenant Protections Study Session: *El Cerrito 2017 Affordable Housing Strategy*, Pillar B: Reduce the Risk of Displacement and Help Stabilize At-Risk Populations**

Action Proposed: Receive a presentation regarding tenant protection tools, discuss policy and program options and provide staff direction towards development of integrated package of tenant protection ordinances.

Presentation and Discussion: Karen Pinkos, City Manager provided an overview of the item. Aissia Ashoori, Management Analyst II, provided a presentation overviewing tenant protection tools, already introduced policies, and policy/program considerations. Staff responded to questions raised by members of the council regarding costs, room rentals, Costa Hawkins application, just cause versus good cause, and legal aide.

Carmela Caramagen regarding relocating rentals if city adopts just cause, and animosity between tenants and landlords.

KC regarding financial impacts of rent increases, and support of a moratorium and just cause eviction.

Norman LaForce regarding just cause, financial implications, balancing interest, and considering selling property.

Elizabeth Thorsnes regarding eviction data, survey instead of rent registry and data monitoring.
