1. **POLICY MATTERS**

A. *Adjourned from February 19, 2019 regular meeting* **Tenant Protections Study Session: *El Cerrito 2017 Affordable Housing Strategy, Pillar B: Reduce the Risk of Displacement and Help Stabilize At-Risk Populations***

Action Proposed: Continued Council discussion regarding tenant protection tools, discuss policy and program options and provide staff direction towards development of integrated package of tenant protection ordinances.

Public Comments:

Lisa Lau regarding support of small business owners and landlord's primary income.

Vincent Lau regarding opposition to rent registry, and tenant relocation.

Leslie Manzone regarding properties not on the market because owners don't want rent control, upcoming legislation on the topic, and status of neighboring communities with rent control.

Ed Crowley regarding history of consideration and current discussion by council, opposition to just cause, stated lack of data.

Blair Akey regarding history as landlord, severity of the problem has not been quantified.

Ranee Estle regarding proposal not addressing the root cause, just cause unsupported, rent control causing decline in rentals.

Norman La Force regarding not knowing the real problem in El Cerrito, forming taskforce of landlords and tenants.

Peter Pan regarding negative financial effects of proposed actions.

Xin Ma regarding opposition to just cause, rent registry and tenant relocation.

Claude Zamanian regarding examples of failed public policy regarding rent controls.

John Lee regarding financial effects of policy proposed.

George Wu regarding desire to purchase a home and deterred by rent control in nearby areas.

Council Discussion: Councilmembers questioned staff and engaged in discussion regarding data collection and cost recovery for rent registry; the need for additional data; potential task force options; access to legal fees; effects on mom and pop landlords; tenant education needs; application to different types of units; temporary cap on rent increases; availability of city staff for administering items discussed; and funding sources.

Action: Passed a motion directing staff to, before business license renewals, bring back an ordinance for a rent registry, covering all rental housing types and discussion of cost recovery. **Moved/Seconded:** Councilmembers Lyman/Fadelli **Ayes:** Mayor Pardue-Okimoto; Councilmembers Fadelli and Lyman. **Noes:** Councilmember Abelson and Quinto

Action: Passed a motion directing staff to work on a just cause for eviction ordinance that applies to buildings with five or more units, built prior to January 1, 2015, including looking at limiting the application of the ordinance based on the type of property owner. **Moved/Seconded:** Councilmembers Lyman/Fadelli **Ayes:** Mayor Pardue-Okimoto; Councilmembers Fadelli, Lyman, and Quinto **Noes:** Councilmember Abelson

Action: Passed a motion directing staff to see if the existing minimum lease ordinance voted on in December needs revision in association with other ordinances and bring back for consideration.

Moved/Seconded: Councilmembers Fadelli/Lyman **Ayes:** Mayor Pardue-Okimoto; Councilmembers Fadelli and Lyman. **Noes:** Councilmember Abelson and Quinto

Action: Passed a motion directing staff to bring back a proposed format for a task force to develop recommendations to further Pillar B of the City's Affordable Housing Strategy, with options of a one-time meeting, a longer dialogue, or an independent collaborator, and associated costs. Task force members should be residents and should be equally made up of landlords and tenants with multitude of building sizes, with a goal of presenting a series of recommendations that would be desirable by both as a working model. **Moved/Seconded:** Councilmembers Abelson/Quinto **Ayes:** Mayor Pardue-Okimoto; Councilmembers Abelson, Fadelli, Lyman, and Quinto **Noes:** None

Action: Failed to pass a motion directing staff to look at an ordinance putting in place a 10% annual increase rent cap, retroactive to December 18, 2018, in place for the duration of time council is working on an overall solution for pillar B, not to exceed on year. **Moved/Seconded:** Councilmember Lyman/Mayor Pardue-Okimoto **Ayes:** Mayor Pardue-Okimoto; Councilmember Lyman **Noes:** Councilmembers Abelson, Fadelli and Quinto

Action: Failed to pass a motion directing staff to bring back a demolition relocation policy for tenants that includes an additional month beyond existing provisions for certain circumstances involving age and disability to five months, with all others at three months. **Moved/Seconded:** Councilmember Fadelli/Mayor Pardue-Okimoto **Ayes:** Mayor Pardue-Okimoto; Councilmember Fadelli **Noes:** Councilmembers Abelson and Quinto **Abstention:** Councilmember Lyman

2. **ADJOURN ADJOURNED REGULAR CITY COUNCIL MEETING** The meeting was adjourned at 7:49 p.m. Mayor Pardue-Okimoto announced a 10-minute recess and that the regular session would convene at 8:00 p.m.
