7:00 p.m. **CONVENE REGULAR MEETING** Chair Milliken called the meeting to order at 7:02 p.m.

2. **ORAL COMMUNICATIONS FROM THE PUBLIC** – None
3. **COUNCIL/STAFF LIAISONS ANNOUNCEMENTS AND REPORTS**  
Provost noted the City Council's formation of an Ad Hoc Subcommittee on Climate Action that followed the City Council's decision to declare a Climate Emergency. The Ad Hoc Subcommittee will be meeting to research and to ultimately provide a recommendation to the broader City Council for how to move forward on updating the Climate Action Plan. Provost also provided an update that the City Council approved of a Green Infrastructure Plan at their September 17 regular meeting.

5. **EQC Workplan 2020**  
EQC Members reviewed and commented on the 2019 EQC Work Plan and Calendar of Events, and participated in a discussion regarding updating the Work Plan for 2020. Milliken outlined the process for updating the work plan. Sobul volunteered to draft the updated work plan to include EQC comments. A discussion was had to decide if the Committee should prioritize focusing on climate action in 2020 or if it should continue to focus on reducing plastic pollution.

EQC Members heard updates, participated in discussion, and considered possible action items regarding planning for the EQC calendar of events, including:

The EQC heard updates and participated in a discussion regarding implementation of the EQC's “Year of Plastic Pollution Prevention”.

- Update on Development of Expanded Foodware Ordinance. Provost provided an update on the Administrative Draft of the Foodware Ordinance and the expected timeline for sharing a Public Draft, doing business outreach, and holding public meetings.

Committee members made announcements and discussed suggestions for future EQC agenda items, including:


